SUBJECT: No Parking 2AM to 6AM Zone on Santa Claus Lane. First Supervisorial District.

RECOMMENDATIONS:

That the Board of Supervisors adopt a resolution establishing a "No Parking 2AM to 6AM" zone on Santa Claus Lane in the Carpinteria area.

ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

EXECUTIVE SUMMARY & DISCUSSION:

Santa Claus Lane is a 30-foot wide minor collector road on the outskirts of Carpinteria paralleling the U.S. 101, with fronting businesses on the south side.

A request was received from the property owners on Santa Claus Lane to implement "No Overnight Parking" in the business district on the north and south sides of Santa Claus Lane, east of Padaro Lane. The large trucks and recreational vehicles often park overnight on both sides of Santa Claus Lane, restricting parking for customers and creating sight distance issues. To create a safer and healthier environment, the Public Works Traffic Section has been asked to prepare the attached resolution establishing a No Parking zone at the following location:

On the north and south side of Santa Claus Lane, from a point 1,349 feet east of the centerline of South Padaro Lane to a point 2,922 feet east of the centerline of South Padaro Lane.
