That the Board of Supervisors adopt a resolution establishing a (2-way) Stop Control on Gray Street at Union Avenue in the Orcutt Area.

EXECUTIVE SUMMARY AND DISCUSSION

The intersection of Gray Street and Union Avenue is a 4-way uncontrolled intersection. A request was received to install stop signs on Gray Street at Union Avenue. An investigation was performed at this intersection to determine whether stop signs were warranted. The results of this investigation showed that there was indeed a need for stops at this intersection due to safety concerns with children walking to and from schools located in the area. Based on our investigation, it was determined that a 2-way stop on Gray Street at Union Avenue would be appropriate. The Public Works Department Traffic Section has prepared the attached resolution to establish a 2-way stop control at the following location:

- On Gray Street at its intersection with Union Ave
