### **Recommended Actions:**

That the Board of Supervisors adopt twelve resolutions establishing No Parking zones on Ortega Hill Road at Pierpont Street, Sycamore Canyon Road at Stoddard Lane, Center Avenue at Walnut Drive, Puente Drive at Puente Plaza (north), Foothill Road at State Route 154, La Cumbre Road at Pueblo Avenue, Modoc Road at Hollister Avenue, Refugio Road at State Route 246, Arcturus Avenue at Alcor Avenue, Harp Road at Clark Avenue, Graciosa Road at Antelope Trail and Black Road at Tanglewood Drive in the 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> Supervisorial Districts.

#### **Summary Text:**

Parking restrictions are either established or rescinded based on safety, necessity and how they relate to the use by the community as a whole. All of these factors are weighed by the Public Works Department and any changes recommended are presented to the Board of Supervisors for approval. These parking restrictions may include no parking, time limited parking, loading zones, vehicle height restricted parking, angle parking, handicapped parking or any combination of these restrictions.

Several requests were received from citizens in the Montecito, Santa Barbara, Vandenberg Village, Los Olivos, Santa Ynez, Santa Maria and the Orcutt areas addressing safety concerns at various locations. In addition, the citizens have requested No Parking zones at several intersections.

Based upon our investigation, the Public Works Traffic Section has prepared the attached resolutions (twelve) establishing No Parking at the following locations:

- On the north side of Ortega Hill Road from the centerline of Pierpont Street to a point 182 feet west of the centerline of Pierpont Street
- On the north side of Sycamore Canyon Road from the centerline of Stoddard Lane to a point 150 feet east of the centerline of Stoddard Lane
- On both sides of Center Avenue from the centerline of Walnut Drive to a point 110 feet east and 100 feet west of the centerline of Walnut Road
- On the west side of Puente Drive from a point 41 feet south of the centerline of Puente Plaza (north) to a point 75 feet south of the centerline of Puente Plaza (north)
- On the north side of Foothill Road from the centerline of State Route 154 northbound on-ramp to a point 640 feet west of the centerline of State Route 154 northbound on-ramp
- On the east side of La Cumbre Road from the centerline of Pueblo Avenue to the centerline of Via Las Brisas
- On the east side of Modoc Road from the centerline of Hollister Avenue to a point 136 feet south of Hollister Avenue
- On both sides of Refugio Road from the centerline of State Route 246 to a point 275 feet south of the centerline of State Route 246
- On the north side of Arcturus Avenue from a point 65 feet north of the centerline of Alcor Avenue to a point 90 feet north of the centerline of Alcor Avenue
- On the east side of Harp Road from the centerline of Clark Avenue to a point 65 south of the centerline of Harp Road
- On the south side of Graciosa Road from a point 53 feet west of the centerline of Antelope Trail to a point 933 feet west of the centerline of Antelope Trail
- On the east side of Black Road from a point 25 feet north of the centerline of Tanglewood Drive to a point 160 feet north of the centerline of Tanglewood Drive and on the east side of Black Road from a point 25 feet south of the centerline of Tanglewood Drive to a point 300 point south of the centerline of Tanglewood Drive
