#### **Recommended Actions:**

Authorize the Chair to execute Amendment No. 1 to extend the date of completion for the existing agreement with Bengal Engineering Incorporated for preliminary design and environmental services for the Floradale Avenue Bridge Replacement, Project No. 862032

#### **Summary Text:**

The preliminary design and environmental contract for the Floradale Avenue Bridge Replacement was awarded to Bengal Engineering, Inc. on October 9, 2007. At that time, the anticipated completion date for the contract was October 9, 2009. Prior to completion of work on this contract, the Federal Highway Administration (FHWA) suspended project funding for approximately six months. During this time period the contract with Bengal Engineering expired. The FHWA reauthorized the funds in December 2009 allowing preliminary design of the new bridge to continue. Therefore staff is requesting that the contract termination date be extended to October 9, 2011. All other terms and conditions of the contract will remain in effect until the amended completion date.

## **Background:**

In 1998 Caltrans and FHWA evaluated all bridges for seismic vulnerability and determined the Floradale Avenue Bridge required either retrofitting or replacement. Retrofitting as a strategy was unacceptable because it would reduce the hydraulic capacity beneath the bridge, which would not meet the requirements of the Federal Emergency Management Agency. As a result, bridge replacement was identified as the best strategy to mitigate seismic impacts at this location.

The Floradale Avenue Bridge replacement project is complex in scope and includes challenges associated with its location, geometry, hydraulic aspects, utilities, right-of-way and environment. Continuation of the work under way on this project will allow the County to fulfill is obligation to address seismic deficiencies as required by the 1998 study. Currently, environmental documents are under review and conceptual design of the bridge is complete.
