Recommended Actions:

That the Board of Supervisors:

- A. Accept and file information regarding CCP membership change to reflect that the Court Executive Officer replaced the Presiding Judge of the Superior Court, as the Santa Barbara County Superior Court representative on the CCP.
- B. Determine that the acknowledgment of the CCP membership change is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15061(b)(3), finding that the activities are covered by the general rule that CEQA applies only to projects which have the potential for causing significant effect on the environment, and where it can be seen with certainty that there is no possibility that the activities in question may have a significant effect on the environment, the activities are not subject to CEQA.

Summary Text:

At the request of the Santa Barbara County Superior Court, the CCP voted on December 7, 2018, to modify membership to reflect that the Presiding Judge of the Superior Court is replaced by the Court Executive Officer, as the Superior Court representative on the CCP

Background:

In 2009, with the passing of Senate Bill 678, also known as the California Community Corrections Performance Incentives Act, Penal Code Section 1230(b)(2) established a local Community Corrections Partnership to advise the Chief Probation Officer on the development and implementation of community corrections programs. Section 1230 directs that CCP membership is to include the Chief Probation Officer as chair, Presiding Judge of Superior Court or designee, a County Supervisor or Chief Executive Officer, the District Attorney, the Public Defender, the Sheriff, a chief of police, the county heads of the Department of Social Services, County Alcohol, Drug, and Mental Health Services, County Office of Education, an employment representative, a representative from a community based organization and a representative of victims interests.

In 2011, following the passing of Assembly Bill 109, known as Public Safety Realignment, an Executive Committee of the CCP was established to recommend a local plan to the county board of supervisors for the implementation of Realignment. Assembly Bill 109 provides that the Executive Committee shall consist of the Chief Probation Officer as chair, the District Attorney, the Public Defender, the Sheriff, a county department head, a chief of police, and the Presiding Judge of Superior Court or designee.

On December 7, 2018, at the request of the Santa Barbara County Superior Court, the CCP voted to appoint the Court Executive Officer as the Superior Court representative on the CCP, in place of the Presiding Judge of the Superior Court.
