SUBJECT: Construction of County Wide 2005/2006 Measure 'D' Miscellaneous Concrete Repair, Tree Root Pruning and Shielding in Santa Barbara County, in the Orcutt Area of the Fourth Supervisorial District. Santa Barbara County Project No. 820605

Recommendation(s):

That the Board of Supervisors:

Accept Notice of Completion for work performed by the Contractor, General Pavement Management, Inc. (not a local vendor), 240 Quail Court, Santa Paula, California 93060, and authorize Clerk to record.

Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Goal No. 1, An Efficient Government Able to Anticipate and Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

This project was part of the annual County Wide, Preventive Maintenance Program of the Department. It consisted of the repair of the existing hardscape and provided 140 linear feet of tree root pruning and shielding. It included the repair and construction of approximately 102 linear feet of sidewalk, 90 linear feet of driveways, 205 linear feet of curbs and gutters, and provided for the installation of 6 federally-mandated curb ramps.

Your Board approved the project as part of the FY 2005/2006 Road Maintenance Annual Plan (RdMap). The specific approved project locations are attached. (See Attachment A for a list of streets.)

The Director of Public Works accepted this project as complete on February 14, 2006. The project was completed on time and on budget.
