#### **Summary Text:**

The Board approved the award of the contract for the FCL Final Closure on January 16, 2007. Work started on the project on March 19, 2007 and was accepted as complete on October 16, 2007.

#### Background:

Land-filling operations started at FCL in about 1970 and came to an end in July 2003 when the landfill reached the limit of its capacity and was declared inactive. The Santa Ynez Valley Recycling & Transfer Station, which is located adjacent to the FCL, commenced operations in July 2003 and now serves the waste disposal needs of the Santa Ynez Valley community. The environmental impacts of the FCL closure activities were evaluated in Environmental Impact Report (90-EIR-14) and Supplemental Environmental Impact Report (97-SD-02).
