SUBJECT: Temporary Stop and One Way Street on North Jameson Lane; First Supervisorial

#### **RECOMMENDATIONS:**

C.A. Recommendation:

That the Board of Supervisors adopt two temporary resolutions as follows:

- A) Adopt a resolution allowing the contractor to temporarily stop traffic at three bridge locations
- B) Adopt a resolution providing for one-way traffic during the construction of North Jameson Lane, Project No. 863027 in the Montecito area.

### ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure

#### **EXECUTIVE SUMMARY & DISCUSSION:**

In the early spring of 2004, construction of North Jameson Lane will commence and last for approximately two (2) years. The project consists in the widening of the roadway and reconstruction of three (3) bridges.

On January 6, 2004, your Board awarded the contract to the lowest responsible bidder. As a part of the project, it was deemed necessary to temporarily stop westbound traffic at Bridge Nos. C-197, C-198, and C-238 for the purpose of bicycle and pedestrian safety.

Due to various stages of construction, "One Way" traffic will be allowed only from east to west between Sheffield Drive and Hixon Road. This action will help expedite the project and will allow westbound motorists and residents access within the construction limits. Eastbound motorists will be detoured or find alternate routes. The Public Works Department recommends that a temporary stop and one way street be designated at the following locations:

- 1) Temporarily stop westbound traffic on North Jameson Lane at bridges No. C-197 and C-198 and temporarily stop east and westbound traffic at North Jameson Lane at Hixon Road.
- 2) Temporarily establish a "One Way" street on a portion of North Jameson Lane east to West from the centerline of U.S. 101 under crossing and the centerline of Hixon Road.
