SECOND AMENDMENT
Effective July 1, 2016

THIS IS THE SECOND AMENDMENT (hereafter referred to as Second Amendment) to the Agreement for STEMI Receiving Center Designation (hereafter Agreement), by and between the County of Santa Barbara (COUNTY) and Marian Medical Center (hereafter HOSPITAL).

WHEREAS, the Agreement is effective through June 30, 2016; and

WHEREAS, the parties desire to amend the Agreement to extend the term and adjust compensation; and

WHEREAS, this Second Amendment incorporates the terms and conditions set forth in the Agreement and the First Amendment, approved by the County of Santa Barbara.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties agree as follows:

1. **Definitions.** Capitalized terms used in this Second Amendment, to the extent not otherwise defined herein shall have the same meanings as in the Agreement.
2. **Amendments.**
 - a. The Agreement is amended as follows:
 4. **TERM.** The term of this Agreement shall be for the period of July 1, ~~2013~~ **2016** through June 30, ~~2016~~ **2018**.
 5. **FEES.** HOSPITAL agrees to pay COUNTY for services provided under the terms of this Agreement: **\$28,432.00** annually for maintaining the STEMI program. This annual service charge shall be paid in full by July 15th of each year of this Agreement, beginning July 15, ~~2014~~ **2016**.
3. **Counterparts.** This Second Amendment may be executed in several counterparts, all of which taken together shall constitute a single agreement between the parties.
