RECOMMENDATION:

That the Board of Supervisors adopt a resolution establishing a 20 Minute Parking Zone between the hours of 8:30a.m. and 5:00p.m. Monday through Friday on Grand Ave in the Los Olivos area.

ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure and Goal #5: Maintain and enhance the quality of life for all residents.

EXECUTIVE SUMMARY & DISCUSSION:

Grand Avenue runs between S.R. 154 and Alamo Pintado Road and is one of the main collector roads running north/south through downtown Los Olivos. The road consists of two travel lanes with on-street angle parking and businesses fronting both sides of the street. The Traffic Section received a request from the Post Master in Los Olivos to paint a green curb to establish a 20 minute parking zone between the hours of 8:30a.m. to 5:00p.m. Monday through Friday on Grand Avenue in front of the post office to better accommodate the public. Based on a field investigation, it was determined by staff that a 20 minute parking zone could be established at the following location:

- On the east side of Grand Avenue from a point 148 feet south of the centerline of Alamo Pintado Avenue to a point 197 feet south of Alamo Pintado Avenue.
