## RESOLUTION HONORING THE AREA AGENCY ON AGING UPON ITS 40<sup>TH</sup> ANNIVERSARY

*WHEREAS, the Central Coast Commission for Senior Citizens, Area Agency on Aging (AAA) is celebrating forty years of serving senior citizens in Santa Barbara and San Luis Obispo Counties; and*

*WHEREAS, the Area Agency on Aging was established through passage of the landmark 1965 Older American's Act which is currently up for reauthorization in the U.S. Congress. Since 1975 the Central Coast Commission for Senior Citizens has been Santa Barbara County's designated AAA; and*

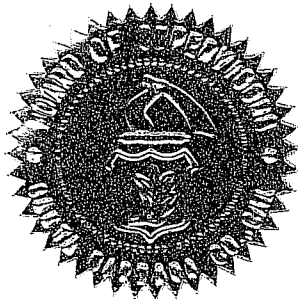
*WHEREAS, the mission of the AAA is to provide leadership in addressing issues that relate to older Californians; to develop community based systems of care that provide services which support independent living and which protect the quality of life of older persons and adults with functional impairments; and to promote citizen involvement in the planning and delivery of services; and*

*WHEREAS, senior citizens age 65 and older are one of the fast growing populations in the United States. According to the U.S. Administration on Aging, the population of seniors was 35 million in the year 2000 and is expected to nearly double to over 71 million by 2030. In addition, those 85 and older are projected to increase from 4.2 million in 2000 to an estimated 9.6 million by 2030; and*

*WHEREAS, the AAA has four major goals that are focused on meeting the needs of our expanding senior population: identify needs and services that benefit older adults; coordinate existing programs, services, and funding sources that serve older persons; explore and plan new resources and funds to meet and expand services for the senior population; and monitor and evaluate senior service programs; and*

**NOW, THEREFORE, BE IT AND IT IS HEREBY ORDERED AND RESOLVED** that this Board of Supervisors honors and commends the Central Coast Commission for Senior Citizens, Area Agency on Aging for its forty years of serving our community.
