Recommended Actions:

That the Board of Supervisors:

- A. Approve and authorize the Chair to adopt: 1) a Resolution establishing "No Parking" zones on El Colegio Road, and 2) a Resolution establishing "No Parking" zones on Camino Corto, in the Isla Vista area, Third Supervisorial District; and
- B. Approve and authorize the Chair to adopt: 1) a Resolution rescinding Resolutions 75-228, 91-329, 05-352, 80-83, 94-452 to remove no parking zones on El Colegio Road and Camino Corto; and 2) a Resolution rescinding portions of Resolutions 71-272, 75-564, 75-917, 76-224, 87-478, 87-520, to remove no parking zones on El Colegio Road and Camino Corto, in the Isla Vista area, Third Supervisorial District.
- C. Approve the filing of a Notice of Exemption pursuant to California Environmental Quality Act (CEQA) Guidelines Section 15301 (c), pertaining to maintenance and operation of existing facilities, for this project.

Summary Text:

The Public Works Department proposes to lengthen the Class 2 bike lanes from the recently-completed El Colegio Road widening projects west to Storke Road. To do this, parking restrictions are needed along the north side of El Colegio Road. To offset the loss of parking spaces on El Colegio Road, Public Works is also proposing adjustments to Camino Corto to maintain the existing travel lanes and bike lanes but add parking to the west side of the roadway. This will result in a net increase of seven

parking spaces available for the public parking in the area. Public Works is recommending that your Board adopt the attached Resolutions to change existing parking restrictions at the locations identified to help with these goals.

The Public Works Department has prepared the attached (4) Resolutions establishing or rescinding parking restrictions at the following locations:

ADOPT

No Parking

- On the north and south sides of El Colegio Road from the centerline of Storke Road to the centerline of Stadium Road.
- On the west side of Camino Corto from the centerline of El Colegio Road to a point 265 feet south of the centerline of El Colegio Road.
- On the east side of Camino Corto from the centerline of El Colegio Road to the centerline of Abrego Road.

No Parking Zones

Rescind the following (9) Resolutions or portions of Resolutions for "No Parking" on El Colegio Road.

Background:

Parking restrictions are either established or rescinded based on safety, necessity and the affect on the community as a whole. The Public Works Department weighs all of these factors and presents any recommended changes to the Board of Supervisors for approval. These parking restrictions may include no parking, time limited parking, loading zones, vehicle height restricted parking, angle parking, handicapped parking or any combination of these restrictions.

El Colegio Road runs in an east-west direction in the Isla Vista area. It connects Storke Road on the west end with The University of California at Santa Barbara (UCSB) on the east end. With the completion of improvements last year, El Colegio Road now has four lanes with bike lanes and no parking on the shoulders. UCSB requested this configuration with bike lanes and no parking be extended from the project limits to Storke Road in front of the buildings they own in that vicinity. This

request is in agreement with Public Works analysis indicating on-street parking should be moved from this location to Camino Corto.

The section of El Colegio Road not included in the recent improvements currently has twenty-three parking spaces and no Class 2 bike lanes. The twenty-three parking spaces are on the north side of El Colegio Road adjacent to the Santa Catalina University Student Housing Facility (formerly Francisco Torres) and used primarily by residents there. There is sufficient off-street parking capacity in the Santa Catalina parking lot to accommodate the parking that is proposed to be removed. Removing these parking spaces will create the space for Class 2 bike lanes.

Camino Corto is currently a two lane road with bike lanes and no parking on both sides of the road from El Colegio Road to Abrego Road. Public Works is recommending rescinding existing parking restrictions on Camino Corto to permit as many as thirty parking spaces on one side of the roadway and still maintain two travel lanes and bike lanes.
