WHEREAS, Dave has had a distinguished career of over 40 years in public and community service. He will be retiring from his numerous positions with the Community Environmental Council (CEC), where he served in the capacities of President and Chairman the Board of Directors, Board Member and Chief Executive Officer, and guided the CEC through a transition from a pioneer in recycling and hazardous waste services to a leader in visioning a clean energy economy for Santa Barbara County; and

WHEREAS, Dave had a distinguished career in public service as the City of Santa Barbara's Community Development Director and City Planner for almost 25 years and previously worked as a planner for the Cities of Long Beach and Thousand Oaks and also taught planning and environmental studies at UCLA and Moorpark College; and

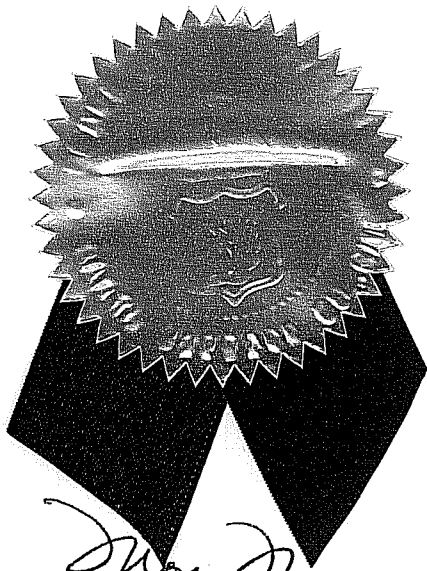
WHEREAS, Dave has used his management and community engagement skills while serving on such local community organizations as the UCSB Foundation Board of Trustees, the UCSB Economic Forecast Project, the Santa Barbara Built Green Advisory Board, the Coastal Housing Coalition, the Santa Barbara Downtown Organization and the Santa Barbara Regional Chamber of Commerce where he served on the Chamber's Business Leaders Council; and

WHEREAS, Dave has received numerous awards, including national recognition for planning innovation from the National League of Cities, social advocacy from the American Planning Association, lifetime achievement from the American Institute of Architects, "Citizen of the Year" and "Excellence in Public Service" awards by the Santa Barbara Downtown Organization, "Planner of the Year" by the Santa Barbara Citizen's Planning Association, "Innovation Star" by the Santa Barbara Regional Chamber of Commerce, recognized in "Leaders in Clean Technology and Sustainability" and "Who's Who in Non-Profits" by the Pacific Coast Business Times, and the "Jacaranda Award" for extraordinary community service from Santa Barbara Beautiful; and

WHEREAS, Dave currently serves as Chair of the Santa Barbara Metropolitan Transit District Board of Directors, sits on the Santa Barbara County Air Pollution Control District Citizen's Advisory Council and is a member of the City of Santa Barbara's Water Commission.
