Adopt Resolution Approving amended Bylaws of the Santa Barbara County Employees' Retirement System

Summary Text:

Government Code Section 31525 provides that the Board of Retirement may make regulations consistent with the County Employees Retirement Law of 1937 and said regulations become effective when approved by the Board of Supervisors. Board of Retirement regulations are incorporated into the Bylaws of SBCERS which, accordingly, require Board of Supervisor's approval. These Bylaws, which make minor procedural changes consistent with SBCERS' current practices, were approved by the Board of Retirement at its April 23, 2014 meeting.

In accordance with best practices for governance, the Board of Retirement periodically reviews the Bylaws. During this most recent review cycle, the following items were addressed by the Board:

- The "retirement administrator" is now referred to as Chief Executive Officer (CEO).
- Clarification of Board of Retirement Operating procedures for production of Board of Retirement meeting minutes, review of conflict of interest code, operating committee and ad hoc committee appointments.

- Appointment of General Counsel as an advisor to the Operations Committee.
- Clarification that County Treasurer-Tax Collector (ex officio) and actively employed (elected general and safety members) are not compensated for attending Board of Retirement and Committee meetings.
- Provide administrative authority to CEO, consistent with past practice, to alter membership dates for new and departing members who are reciprocal, in order to ensure that no overlap in service time exists between two public employers.
