We respectfully submit these Public Comments for the Supervisors Hearing May 19, 2020. Thank you.

Dear Supervisors,

Our Group "ReOpen Santa Barbara – Post Your Best Ideas" has continued to generate many good ideas for the safe and speedy reopening of Santa Barbara County, with now over 1100 ideas and comments being posted. We will share some of them below.

I'm afraid we need to also report that the tone of the conversation has taken on a harder edge, with more and more people expressing anger and frustration with the continued lockdown. To summarize: we did what Sacramento asked, we stayed home to flatten the curve, and we accomplished that 4-5 weeks ago. And now in a county with very few deaths and active cases (outside of the Lompoc Prison numbers) we remain trapped in economic limbo.

The Governor says 70% of CA economy is still operating, but we all know that in SB county its likely closer to the inverse—maybe we're operating at 30% capacity—given how much our hospitality, restaurant, wine, tour, and retail businesses rely on tourism.

It is time for the Board of Supervisors to do more. It is time for you folks to take the decision making out of the hands of Sacramento.

Maybe Sacramento's rules and restrictions make some sense for some other counties, where going on wet sand but not dry sand at the beach seems logical. But they don't make sense here. We have the virus under control, we aren't overwhelming the hospitals, hardly anyone has died and very few outside of Lompoc Prison are "active cases".

Santa Barbara is ready to reopen, people are done with the quarantine and you can see it when you go for a walk or bike ride....3 weeks ago most people had a mask on. Two weeks ago maybe half. Last week about 20%, and this weekend maybe 5%.

Call it the 'mask indicator'...People are angry and frustrated and they're going to start expressing that in non-positive ways if we don't do something soon.

Your efforts in the past weeks have been admirable, but Sacramento is not listening. So you need to ask yourselves the following questions:

- --What are we doing differently TODAY to put pressure on the Governor to separate out the prison numbers from the rest of the county?
- --What are you doing TODAY to remove the 'new cases' requirement?
- --What are you doing TODAY to make it clear to the Governor that SB County is not like other places in California, and we are ready and need to begin reopening NOW.

Our focus at "ReOpen Santa Barbara remains on the positive, and in that spirit we commend to you some of the ideas posted this past week:

- 1) Reopen the schools. People cannot go to work if they need to stay home to care for their children. The data and science support this decision, and it is a necessary first step to get the economy going again. (credit: Laura Hout)
- 2) Band together with other nearby counties, Ventura and SLO eg, to form a 'voting block' of sorts to carry more weight in negotiations with Sacramento. (credit: Timothy Brummer).
- 3) Reopen the Goleta Drive-In theater and similar venues so we can enjoy movies (and maybe concerts) in our cars. (credit: Alix Seeple)

Public Comment from Brian Goebel and Cori Hayman Re Board of Supervisors Meeting, May 19th, Item D-1; 20-00281 (COVID-19).

Dear Chair Hart and Members of the Board of Supervisors,

Thank you for your continuing leadership during the COVID-19 Crisis. We have two items on which we would like to provide public comment.

The Board of Supervisors Should Approve the RISE Framework

We support the RISE framework and believe that its criteria for assessing when to change public health measures are far more appropriate than those set forth by the Governor. We encourage the Board to adopt it as a living document throughout the reopening process.

<u>The Board of Supervisors Must Pursue Additional Options to Lift the Stay at</u> Home Order

The Governor has failed to respond to the Board's letter seeking revisions to the epidemiological criteria requiring no death over a 14-day period and 1 positive case per 10,000 over the same period. The Board must therefore explore additional mechanisms for seeking relief from the Governor's case and fatality criteria so that the County may file its attestation and loosen its public health measures more rapidly than the State (*i.e.*, proceed more rapidly through Stage 2). We encourage the Board to publicly support the efforts being pursued jointly by Riverside, San Bernardino, and Orange County to obtain relief from the Governor's criteria.

Finally, we would like to respectfully remind the Board of each member's oath of office to uphold the Constitution in fulfilling his or her obligations in representing the people of the County. As previously stated, the legal and policy basis supporting the exercise of police power in the form of the statewide stay at home order was to ensure adequate healthcare capacity to treat a surge of COVID-19 patients. It has been clear for 6 weeks that California has adequate healthcare capacity, and hospitalizations continue to fall. Moreover, instead of a statewide COVID-19 emergency, California now faces a chronic COVID-19 outbreak in Los Angeles County (which accounts for the majority of COVID-19 activity in the State)

and stable or improving conditions virtually everywhere else. It is hardly clear how a *statewide* emergency can be justified on these facts. The people of Santa Barbara County have complied with the order for two months now and are facing an economic and social disaster of catastrophic proportions. Hospital admissions remain very low (27 as of May 17th), even with the prisoner population. There is no legal or policy justification supporting the current statewide stay at home order and the Governor's continuing action is treading on unconstitutional grounds. We would therefore encourage the Board to ask County Counsel to prepare an opinion discussing the Board's legal options for seeking relief from the Governor's criteria, including its ability to move beyond Stage 2 under its own criteria, and that the Board hold a special meeting to discuss reopening strategies prior to the next regularly scheduled Board meeting.¹

My name is Sarah Henderson and I would like to submit the following public comment for the City Council Meeting on May 19 2020, for Item 6: Sheriff, Probation. If possible I would like my comment read into the record:

"The County jail facilities pose risks to the health of incarcerated people. Currently, inmates who leave the facility or are in contact with people outside of the facility are forced to endure a two week quarantine, which is easily comprable to solitary confinement, a form of torture. We demand that this quarantine not be required and instead be replaced with requiring all parties to wear appropriate PPE when in contact with an incarcerated person, as well as with accessible testing upon reentry of the facility. Additionally, conditions in the South County facility are unsafe and unsuited to handle the current crisis. As such, we demand that the current population be relocated to the North County facility, which would not only be safer for those incarcerated but would also cut operational and staffing costs."
