SUBJECT: Dr. Olivia Landicho and Dr. James Deming Contracts.

Recommendation(s):

That the Board of Supervisors:

1. Approve and execute a personal services contract in the amount of \$33,000, with Olivia Landicho, M.D., a local vendor, to provide psychiatric services to mentally ill and emotionally disturbed clients in Santa Barbara County ADMHS clinics. The contract term is from October 10, 2005, through June 30, 2006.
2. Approve and execute a personal services contract in the amount of \$194,000, with James Deming, M.D., a local vendor, to provide psychiatric services to mentally ill and emotionally disturbed clients in Santa Barbara County ADMHS clinics. The contract term is from September 1, 2005, through June 30, 2006.
3. Authorize the Director of ADMHS to approve amendments to the proposed contract, provided that any such amendments do not exceed ten percent (10%) of the contract's dollar amount.

Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 2. A Safe and Healthy Community in Which to Live, Work and Visit.

Executive Summary and Discussion:

Olivia Landicho, M.D. and James Deming M.D. are part of a group of Contractor-On-Payroll psychiatrists providing staffing to the Calle Real, Lompoc, and Santa Maria Clinics in Santa Barbara County. This group

of doctors perform diagnostic, medication, and involuntary admission evaluations, prescribe and administer medication, and provide training, education and support to ADMHS staff and/or Multi-Disciplinary Team members as needed. Dr. Deming will work approximately 40 hours per week in the Calle Real and Lompoc Clinics while Dr. Landicho will work approximately 10 hours per week for the North County Supportive Housing Program, SHIA.

Performance Measures:

Dr. Landicho and Dr. Deming's contracts will help ADMHS meet **Recurring Performance Measure 0215**, to provide effective mental health care to 4,200 adults receiving mental health services. The doctors are expected to perform 10-40 medical evaluations per work week.

Mandates and Service Levels:

Mental Health Services are mandated by the Welfare and Institutions Code, Section 5600.

Fiscal and Facilities Impacts:

These contracts are funded by Medi-Cal and Realignment. These funding sources are identified in the Adopted FY 2005-06 Budget, Federal and State Funding, Medi-Cal line item 5405; and, Realignment funds line item 4102, in the County Budget Book, Adult Services Division page D-150.

These actions will not result in a need for any additional facilities.
