SUBJECT: No Parking 2AM to 5AM Zone on Cathedral Oaks Road and Via Chaparral Road. Second Supervisorial District.

RECOMMENDATION:

That the Board of Supervisors adopt a resolution establishing a "No Parking 2AM to 5AM" zone on Cathedral Oaks Road and Via Chaparral Road in the Goleta area.

ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

EXECUTIVE SUMMARY & DISCUSSION:

Cathedral Oaks Road is a 50-foot wide major collector road located in the Goleta area. Via Chaparral Road is a 40-foot wide minor residential street that extends north from Cathedral Oaks Road.

A request was received from a property owner who resides on Via Chaparral Road asking to implement "No Overnight Parking" on both sides of Via Chaparral and the north side of Cathedral Oaks Road. The resident is frustrated due to the many vehicles being parked overnight with the intention of displaying signs advertising them for sale. To address this issue, the Public Works Traffic Section has been asked to prepare the attached resolution establishing No Parking zones at the following location:

- A. On the north side of Cathedral Oaks Road, from the centerline of the State Route 154 southbound off ramp to the centerline of Via Chaparral Road.
- B. On both sides of Via Chaparral Road from the centerline of Cathedral Oaks Road to the centerline of La Paloma Avenue.
