That the Board of Supervisors:

Accept the Irrevocable Offer to Dedicate an Easement across Las Gaviotas Private Road and a portion of the property located at 3101 Cliff Drive, in the City of Santa Barbara, County of Santa Barbara, for the continued maintenance of a portion of Arroyo Burro Beach Park by approving the Resolution Accepting Offer to Dedicate Easement For Park Maintenance Purposes and directing the Clerk of the Board to execute the Certificate of Acceptance.

Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with actions required by law or by routine business necessity.

Executive Summary and Discussion:

In 1979, the owners of the property located at 3101 Cliff Drive, in the City of Santa Barbara, County of Santa Barbara, and immediately adjacent to Arroyo Burro Beach Park, applied to the California Coastal Commission for a development permit. The Commission, acting on behalf of the People of the State of

California, granted Coastal Development Permit A-44-79, which allowed the owners to subdivide the 7.8 acre bluff top parcel into five developable parcels, upon certain conditions. One such condition required the owners of the property to make an irrevocable offer to dedicate to the County of Santa Barbara as owners and operators of the Park, an easement for emergency and routine maintenance of a portion of the Park.

The easement would extend from Cliff Drive, across the existing private road which is now Las Gaviotas Road, and then across Lot No. 5 of the proposed subdivision. The purpose of the easement was to allow the Santa Barbara County Parks Department access to the elevated portion of the Park to conduct routine and emergency maintenance. As required, the owners recorded an Irrevocable Offer to Dedicate the easement to the County in the official records of the Santa Barbara County Clerk Recorder on August 27, 1979, as Document Number 79-39877

The period of irrevocability of the offer to dedicate the easement was determined to be twenty-five years from the date of recordation of the offer, and would bind successors and assigns of the owner. The subdivision was completed according to the Development Permit granted by the Commission. Parcel 5 of the subdivision became County Assessor Parcel Number 047-092-018. Since that time, Our County Parks Department has been utilizing the easement for the intended purposes of routine and emergency maintenance of the upper portion of the Park.

Although there have been no issues regarding Parks' use of the easement area, the Parks Department has determined that it is in the best interest of the County to memorialize the easement by recording our formal acceptance of the Irrevocable Offer prior to its expiration. Therefore, your approval and execution of this Resolution will direct General Services to record the Resolution formally accepting the Irrevocable Offer and preserving the County's right to continued use of the easement area in perpetuity.

RESOLUTION ACCEPTING OFFER TO DEDICATE EASEMENT FOR PARK MAINTENANCE PURPOSES

APN: 047-092-018 (portion)

WHEREAS, on April 4, 1979, the California Coastal Commission, acting on behalf of the People of the State of California, granted Coastal Development Permit A-44-79 to the owners of the property located at 3101 Cliff Drive, in the City of Santa Barbara, County of Santa Barbara, for the division of a 7.8 acre bluff top parcel immediately adjacent to Arroyo Burro Beach Park, upon certain conditions; and

WHEREAS, one such condition required the owners of the property to make an irrevocable offer to dedicate to the County of Santa Barbara an easement for emergency and routine maintenance of the neighboring Arroyo Burro Beach Park, where such easement would extend from Cliff Drive across the existing private road and Lot No. 5 of the proposed subdivision, to a portion of the Park; and

WHEREAS, the property was subdivided and Lot No. 5 of the proposed subdivision became the parcel commonly known as Santa Barbara County Assessor Parcel Number 047-092-018, the existing private road is now known as Las Gaviotas, and Arroyo Burro Beach Park is operated by the Santa Barbara County Parks Department; and

WHEREAS, the period of irrevocability of the offer to dedicate the easement was determined to be twenty-five years from the date of recordation of the offer, and would bind successors and assigns of the owner; and

WHEREAS, the Irrevocable Offer to Dedicate the easement was recorded in the official records of the Santa Barbara County Clerk Recorder on August 27, 1979, as Document Number 79-39877; and

WHEREAS, the County of Santa Barbara wishes to accept said Irrevocable Offer to Dedicate prior to its expiration by recording this Resolution Accepting Offer to Dedicate Easement for Park Maintenance Purposes.

NOW, THEREFORE, BE IT RESOLVED, the Santa Barbara County Board of Supervisors does hereby find, determine and order as follows:

- 1. The above recitals are true and correct; and
- 2. A copy of the Legal Description describing the original 7.8 acre parcel that was subdivided as Parcel One, Lot No. 5 of the subdivision (now APN 047-092-018) as Parcel Two, and the existing private road (now Las Gaviotas) as Parcel Three, is attached hereto and incorporated herein by reference as Exhibit "A"; and
- 3. That on behalf of the People of the State of California and of the County of Santa Barbara, the Board of Supervisors of the County of Santa Barbara, State of California, hereby accepts the easement as described in the Irrevocable Offer to Dedicate, Document Number 79-39877, as recorded in the official records of the Santa Barbara County Clerk Recorder's Office by executing the Certificate of Acceptance; and
- 4. That this Resolution be recorded in the Santa Barbara County Clerk Recorder's Office.
