Recommended Action(s):

- A) Enter into a contract with Thomas Walters and Associates for federal advocacy/lobbying services for the period of December 23, 2006 through December 28, 2008.
- B) Approve the attached budget revision transferring \$84,000 from Contingency to pay for the cost of one year of the federal lobbyist contract.

Summary:

On November 21, 2006, the Board of Supervisors authorized the CEO to assess the feasibility and cost of retaining a federal lobbyist by conducting a "Request for Qualification" (RFQ) process. Based on the responses the County received from its RFQ, staff is recommending that the Board enter into a contract with Thomas Walters and Associates, Inc, for a period of December 23, 2006-December 28, 2008 for an amount of \$84,000 for the first year and inclusive of a cost of living adjustment for the second year.

Background:

This item is on the Board's agenda in order to allow the County to enter into contract with Thomas Walters and Associates for federal advocacy/lobbyist services. A RFQ was issued on November 29, 2006 and eight proposals were received by the December 6, 2006 deadline. The firm, Thomas Walters and Associates, was selected based on the evaluation criteria outlined in the RFQ (firm's background and qualifications, expertise/understanding of the County's legislative priorities, fees, client list and references and writing sample). The RFQ and the response from the firm are attached.

Performance Measures:

The evaluation of the performance of the contractor will be based on the firm's ability to garner legislative support and funding for key projects and issues facing the County as identified in the County's 2007 legislative priorities.
