

**FIRST AMENDMENT TO AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR FOR
VERINT WORKFORCE MANAGEMENT SYSTEM UPGRADE**

First Amendment

This is a *First Amendment* (*First Amendment to the Agreement*) to the Agreement for Services of Independent Contractor, by and between the **County of Santa Barbara** (COUNTY) and **NEC Corporation of America dba NEC(NEW) Corporation of America** (CONTRACTOR).

WHEREAS, on April 20, 2021, COUNTY approved the Agreement for Services of Independent Contractor, number BC# 20-266, (Agreement) with CONTRACTOR for the provision of Verint Workforce Management System Upgrade;

WHEREAS, the initial term of the Agreement commenced on May 1, 2021, and is set to expire on July 31, 2021; and

WHEREAS, the parties now desire to amend Agreement to extend the term through December 31, 2021 (First Extension Period).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, COUNTY and CONTRACTOR agree as follows.

The Agreement is amended as follows:

1. Section 4, **TERM**, of the Agreement is amended by adding the following language:

For the First Extension Period, CONTRACTOR shall commence performance on **May 1, 2021** and end performance upon completion, but no later than **December 31, 2022** unless otherwise directed by COUNTY or unless earlier terminated.

2. Section A of EXHIBIT B, Payment Arrangements, is amended to state in its entirety:

A. For CONTRACTOR services to be rendered under this Agreement, CONTRACTOR shall be paid a total contract amount, including cost reimbursements, not to exceed **\$7,580.32** for the period of *May 1, 2021 through December 31, 2021*.

In all other respects, the Agreement remains unchanged and shall remain in full effect.
