- a) Approve and authorize the Chair to execute the Statement of Final Quantities for work performed and materials supplied for the Cold Springs Debris Basin Expansion Project by the contractor Raminha Construction, Inc. (a tri-county vendor), in the amount of \$723,345.12; and
- b) Find that pursuant to the California Environmental Quality Act Guidelines section 15162, no substantial changes are proposed, there are no substantial changes in circumstances and no new information of substantial importance has come to light regarding environmental effects of the project or feasibility of mitigation measures and, therefore, this action is within the scope of the project covered by the Final Mitigated Negative Declaration (19NGD-00000-00015) for the Cold Springs Debris Basin Expansion Project, and therefore, no subsequent environmental document is required. **Summary Text:**

This item is on the agenda in order to obtain Board approval and authorization to execute the Statement of Final Quantities (SFQ) for the Cold Springs Debris Basin Expansion Project. On July 14, 2020, the

Board entered into an agreement with Raminha Construction, Inc. for this project for \$695,750.00 and a contingency authorized for \$47,287.50, for a total authorized amount of \$743,037.50. This project was completed at a cost of \$723,345.12.

The Flood Control District has accepted the work of the contractor Raminha Construction, completed on time and per plans and specifications. On October 5, 2020, the Notice of Completion for this project was sent to the Clerk Recorder’s office to be recorded.

**Background:**

On January 9, 2018, the 1-9 Debris Flow filled and overtopped the Cold Springs Debris Basin (as well as many other debris basins below the Thomas Fire area). The Cold Springs Debris Basin Expansion Project involves increasing the line and grade of the basin beyond the limits of its original design (designed by the Corps of Engineers in 1964) to enlarge the basin to the west, within existing District owned property.
