#### **Recommended Actions:**

- a) Recognize and approve that the County of Santa Barbara, City of Santa Barbara, City of Lompoc and City of Santa Maria have agreed to combine designated FY2022 JAG funding for the purposes of maintaining, training and equipping the Santa Barbara Countywide Bomb Squad;
- b) Authorize the Sheriff or his designee to execute a grant agreement with the United States Department of Justice, upon review and approval of County Counsel and the Auditor-Controller, or their designees, when the anticipated JAG funding is awarded;
- c) Approve BJE #0008606 to increase appropriations of \$113,363.00 in Sheriff General Fund for Capital Assets Equipment (\$113,363.00) by unanticipated revenue from Intergovernmental Revenue Federal;
- d) Authorize the Chief Executive to execute the "Certifications and Assurances by the Chief Executive of the Applicant Government" form and the Inter-Local Agreement between the City of Santa Barbara and the County of Santa Barbara, the Inter-Local Agreement between the City of Santa Maria and the County of Santa Barbara and the Inter-Local Agreement between the City of Lompoc and the County of Santa Barbara;
- e) Find that the proposed action does not constitute a "Project" within the meaning of the California Environmental Quality Act (CEQA), pursuant to 14 CCR 15378 (b)(4), in that it involves government funding mechanisms and/or fiscal activities.

#### **Summary Text:**

If awarded, Santa Barbara County will use the \$113,363.00 in proposed FY2022 Edward Byrne Memorial Justice Assistance Grant (JAG) funds for the purposes of maintaining, training and equipping the Santa Barbara Countywide Bomb Squad. The JAG funding will be utilized to update and purchase capital assets for the Santa Barbara Countywide Bomb Squad. This JAG project will positively impact our local communities by providing updated equipment for the Santa Barbara Countywide Bomb Squad, which serves the entire County of Santa Barbara.

#### Background:

Santa Barbara County has received Edward Byrne Memorial Justice Assistance Grant (JAG) funds for more than 25 years. The Local JAG program is a formula grant that is awarded to local governments. It is administered by the United States Department of Justice, Office of Justice Programs' Bureau of Justice Assistance. The JAG grant supports a broad range of activities to prevent and control crime and enhance the justice system. The procedure for allocating JAG funds is based upon a formula that is derived from population and crime statistics. The allocation formula favors high density municipalities, which is corrected by the use of a "disparate funding" provision. Within the proposed FY2022 funding, the Cities of Santa Barbara and Santa Maria and the County of Santa Barbara were identified as a disparate jurisdiction, requiring a joint application between the three entities. The Cities of Santa Barbara and Santa Maria have agreed to enter into an MOU with the County of Santa Barbara and submit a joint "disparate" application. In addition, the City of Lompoc has also agreed to pool their allotted JAG funding and submit a single JAG application for the entirety of Santa Barbara County and to utilize this funding for the purposes of maintaining, training and equipping the Santa Barbara Countywide Bomb Squad.

The County Law Enforcement Chiefs (CLEC) historically worked together to develop the allocation plan for the JAG funds, as well as other grants and asset forfeiture revenue. In 2022, CLEC member agencies affirmed their commitment to the Santa Barbara Countywide Bomb Squad and agreed to a JAG funding allocation plan that will assist in continuing the operation of the Countywide Bomb Squad by purchasing and updating equipment during the FY2022/2023/2024/2025. In essence, the proposed JAG funds will be administered by the Sheriff's Office, who will utilize the JAG funds for the purposes of maintaining, training and equipping the Santa Barbara Countywide Bomb Squad. The Sheriff's Office has agreed to submit the sole JAG application for Santa Barbara County and will be responsible for completing reporting requirements mandated by the grant administrator (Department of Justice – OJP/BJA).

For FY2022, the Department of Justice has included a requirement in the form of certifications that must be signed by the Chief Executive and Chief Legal Officer of the County prior to the receipt of any grant funds (Exhibit A).

If awarded, FY2022 JAG funds will be utilized to support the Santa Barbara Countywide Bomb Squad within the county to purchase new equipment and maintain and upgrade existing equipment. Local JAG funds will not be released by the Department of Justice until 30 days after the Board of Supervisors reviews the Local JAG funding proposal and the public is given an opportunity to provide comment of the use of Local JAG funding.

The Santa Barbara Countywide Bomb Squad is Santa Barbara County's only public safety bomb squad. The Santa Barbara Countywide Bomb Squad was formed in 1971. It was formed by the Santa Barbara County Sheriff's Office in response to domestic bombings that were occurring around the country. The Bomb Squad is responsible for the safe disposal of actual or suspected explosive devices, deteriorated explosives, illegal fireworks, improvised explosive devices (IED's), and military ordnance. The bomb squad also provides assistance to local, state and federal agencies and provides assistance with dignitary protection of persons coming to the area. The FBI certifies each of the bomb technicians and oversees the national bomb technician program.

The goals of the Santa Barbara Countywide Bomb Squad are:

- 1. To investigate, render safe and dispose of suspected hazardous devices, explosives, explosive materials (as the Bureau of Alcohol, Tobacco, Firearms and Explosives currently defines) and pyrotechnics ammunition within Santa Barbara County.
- 2. Coordinate investigations with local, state and federal partners.
- 3. Perform diagnostics and render safe procedures in Chemical, Biological, Radiological, Nuclear and Explosive (CBRNE) events within Santa Barbara County.
- 4. Conduct bomb crime scene investigations.
- 5. Collect and preserve evidence.
- 6. Provide technical support to special operations, dignitary protection and special events.

The Santa Barbara Sheriff's Office will administer the combined JAG funding for the county and all applicable cities within the county, and will serve as the sole point of contact for the DOJ - OJP/BJA grant administrators.

This Agreement is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_\_, 20\_\_\_, by and between The County of Santa Barbara, acting by and through its County Executive Officer or designee, hereinafter referred to as COUNTY, and the City of Santa Barbara, acting by and through its City Administrator or designee, hereinafter referred to as CITY, both of Santa Barbara County, State of California.

WHEREAS, the Agreement is made for the purpose of jointly applying for an award of Federal Fiscal Year 2022 Justice Assistance Grant (JAG) Program funds (JAG Funds); and

WHEREAS, the CITY has been certified as a disparate jurisdiction under the JAG Program; and

WHEREAS, the COUNTY has been allocated JAG Funds in the amount of \$17,535.00 and the CITY has been allocated JAG Funds in the amount of \$30,755.00 for a total amount of \$48,290.00 as the aggregate allocation to the CITY and COUNTY; and

WHEREAS, the COUNTY anticipates receiving as the applicant and fiscal agent under the JAG Program, an aggregate allocation of \$113,343.00 of JAG Funds derived from the sum of the allocations to the CITY, COUNTY and the cities of Lompoc and Santa Maria, to be used for the Santa Barbara Sheriff's Bomb Squad (a county wide response team); and

WHEREAS, the CITY anticipates the COUNTY will utilize the available aggregate Local JAG Funds administered by the COUNTY, over the course of the JAG funded project toward the costs of maintaining, equipping and training the Santa Barbara Bomb Squad (a county wide response team), and the CITY anticipates the COUNTY will utilize the remaining aggregate JAG Funds to reimburse the CITY and other participating local law enforcement agencies for costs incurred by the CITY while participating in or supporting maintaining, equipping and training the Santa Barbara Bomb Squad (a county wide response team), over the course of the JAG funded project.

WHEREAS, the governing bodies of the COUNTY and the CITY find the performance of the Agreement is in the best interests of both parties, the undertaking will benefit the public, and the division of costs fairly compensates the performing party for the services or functions under the agreement; and

WHEREAS, the CITY agrees to provide the COUNTY \$30,755.00 from the JAG award solely for the Countywide Bomb Squad; and

WHEREAS, the CITY and COUNTY agree supplanting is prohibited under the JAG Program;

## NOW THEREFORE, the COUNTY and CITY agree as follows:

## Section 1

The CITY agrees to participate in a joint application for the award of JAG Funds to be used toward the maintaining, equipping and training the Santa Barbara Bomb Squad (a county wide response team) and to designate its allocation of JAG Funds in the amount of \$30,755.00 as part of a joint JAG Project proposal. The CITY further authorizes the COUNTY to submit a joint application / JAG Project proposal to the Department of Justice for the 2022 Byrne Justice Assistance Grant (JAG) Program.

#### Section 2

County shall serve as the applicant and fiscal agent that shall submit the joint application for the aggregate allocation of JAG Funds in the total amount of \$113,343.00 derived from the sum of the allocations to the CITY, COUNTY and cities of Lompoc and Santa Maria, to be used for the Countywide Bomb Squad.

#### Section 3

The CITY agrees the CITY's allocation of JAG Funds may be distributed by the COUNTY to other member agencies, to be used for the operation of the Countywide Bomb Squad. The COUNTY agrees to utilize JAG Funds solely to pay for maintaining, equipping and training the Santa Barbara Bomb Squad (a county wide response team), and to reimburse the CITY for the costs incurred by the CITY while participating in or supporting the maintenance, equipping and training of the Santa Barbara Bomb Squad (a county wide response team), utilizing available aggregate Local JAG Funds administered by the COUNTY, over the course of the JAG Funded Project.

#### Section 4

The CITY agrees to have COUNTY administer the total amount of JAG Funds awarded to the COUNTY and the CITY pursuant to the joint application. As the administrator, the COUNTY shall be responsible for the administration of the joint JAG Funds awarded; monitoring the award; submitting reports, including performance measure and program assessment data; and, providing ongoing technical assistance to the CITY and other subrecipients of the JAG Funds.

The debts, liabilities, and obligations of each party shall not be debts, liabilities, and obligations of the other party.

#### Section 6

The CITY agrees to provide and make available to COUNTY proper supporting documentation to ensure audit compliance and compliance with all applicable legal requirements.

#### Section 7

The parties to this Agreement do not intend for any third party to obtain any right by virtue of this Agreement. This Agreement shall not create any rights in, for, or on behalf of any party not a signatory hereto.

#### Section 8

By entering into the Agreement, the parties do not intend to create any obligations express or implied other than those set out herein.

#### Section 3

The COUNTY agrees to utilize JAG Funds to pay for maintaining, equipping and training the Santa Barbara Bomb Squad (a county wide response team), and to reimburse the CITY for the costs incurred by the CITY while participating in or supporting the maintenance, equipping and training of the Santa Barbara Bomb Squad (a county wide response team) utilizing available aggregate Local JAG Funds administered by the COUNTY, over the course of the JAG Funded Project.

#### Section 4

The CITY agrees to have COUNTY administer the total amount of JAG Funds awarded to the COUNTY and the CITY pursuant to the joint application. As the administrator, the COUNTY shall be responsible for the administration of the joint JAG Funds awarded; monitoring the award; submitting reports, including performance measure and program assessment data; and, providing ongoing technical assistance to the CITY and other subrecipients of the JAG Funds.

#### Section 5

Each party to this Agreement shall be responsible for its own actions under this Agreement and shall not be liable for any claims, actions, losses, liabilities, damages, judgments, costs, or expenses, including attorney's fees, that arise from, are connected with, or are related to any acts or omissions in the performance, attempted performance, or non-performance of the Agreement by the other party. The debts, liabilities, and obligations of each party shall not be debts, liabilities, and obligations of the other party.

#### Section 6

The CITY agrees to provide and make available to COUNTY proper supporting documentation to ensure audit compliance and compliance with all applicable legal requirements.

#### Section 7

The parties to this Agreement do not intend for any third party to obtain any right by virtue of this Agreement. This Agreement shall not create any rights in, for, or on behalf of any party not a signatory hereto.

#### Section 8

By entering into the Agreement, the parties do not intend to create any obligations express or implied other than those set out herein.
