**AMENDMENT NO. 4 TO AGREEMENT FOR PROFESSIONAL LEGAL SERVICES
(CONTRACT NO. BC19305)**

This Amendment No.4 amends the Agreement for Professional Legal Services as previously amended (“AGREEMENT”) between the County of Santa Barbara (“COUNTY”) and Ice Miller LLP (“ATTORNEY”).

The parties hereby amend the AGREEMENT as follows:

Section 4, Term is replaced with the following:

ATTORNEY shall commence performance on April 9, 2019 and end performance upon completion, but no later than August 31, 2027, unless otherwise directed by COUNTY, or unless earlier terminated.

Section A of Exhibit B Payment Arrangements is replaced with the following:

- A. For ATTORNEY services to be rendered under this AGREEMENT, ATTORNEY shall be paid a total contract amount, including cost reimbursements, not to exceed \$115,000.
