Accept Notice of Completion for work performed by the Contractor, Granite Construction Co, a California corporation (Not A Local Vendor), P.O. Box 50085, Watsonville, California 95077 and authorize Clerk to record.

Alignment with Board Strategic Plan:

The recommendation is primarily aligned with Goal No. 1, An Efficient Government Able to Anticipate and Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

This project consisted of removing and repairing approximately 969 square yards of failed areas in the existing pavement, cold planing approximately 49,392 square yards of existing pavement, placing approximately 21,220 square yards of pavement reinforcing fabric, 51.5 lineal feet of curb & 18" gutter, 11 access ramps, and placing an asphalt concrete overlay on approximately 7.02 lane miles of County maintained roadway.

The Director of Public Works accepted the contract on September 3, 2003.

The project was completed on time and under the budgeted contract amount.



Mandates and Service Levels:

No change in program or service level.

Fiscal and Facilities Impacts:

Funding for this project has been allocated through the Transportation Enhancement Activities (TEA) – 21 Lois Capps Demonstration Project, a federal program administered by Caltrans. \$776,387.45 of TEA-21 Lois Capps Demonstration Project revenues will be provided for this project. The local match of \$194,096.85, is being funded with Measure D revenues and have been budgeted in Fund 0015, Program 2900, Org. Unit 0002, Department 054 and Account 7511.
