Recommended Actions:

That the Board of Supervisors:

- a.) Approve and authorize the Chair to execute an Agreement for Services of Independent Contractor with Community Solutions, Inc. (a not-for-profit organization) to provide program delivery services targeted towards medium – high risk inmates incarcerated at the Santa Barbara County Main Jail and the North Branch Jail for the period of July 1, 2019 to June 30, 2020 in an amount not to exceed \$470,000.00; and
- b.) Find that the proposed actions do not constitute a “Project” within the meaning of the California Environmental Quality Act (CEQA), pursuant to 14 CCR 15378(b)(5), in that they are government administrative activities that will not result in direct or indirect changes to the environment.

Summary Text:

Community Solutions, Inc. will provide case management (1 FTE) and counseling services (5 FTE's) such as individual screening and assessment, intake, brief case management, brief individual counseling, facilitation of evidence based correctional groups, discharge planning and coordination of discharge services with the countywide discharge planning team. However, the bulk of the time spent shall be on facilitating and teaching cognitive behavioral training programs in-group settings.

Background:

In order to broaden programming and provide intensive and appropriate services to all higher risk populations, the Community Corrections Partnership (CCP) has provided funding to contract services.

Contracted services will be expanded to deliver other evidence-based learning and rehabilitation opportunities for inmates in the Santa Barbara County Main Jail and the new North Branch Jail. This expansion will increase the delivery of targeted Cognitive Behavioral Therapy interventions and discharge planning services for STP participants, as proven most effective in reducing the recidivism of the communities most costly criminal offenders.
