Subject: General public comment, BOS meeting of 10/21/25

On July 15, 2025, during a Board of Supervisors meeting, the Third District Supervisor stated that the actions of DHS/ICE agents were comparable to those of the Nazi SA (Brownshirts). The SA engaged in the murder of political opponents of the National Socialist German Workers Party (Nazis).

Before 1933, the actions of the SA were unlawful under German law. DHS/ICE agents are acting under the authority of laws enacted, with bipartisan support, by Congress. There is no comparison.

During the past 9 months, a coordinated effort involving elected officials, government employees and NGOs, have attempted to interfere with DHS/ICE immigration enforcement operations. This effort includes labeling DHS/ICE agents as Nazis, kidnappers and terrorists, then directing incited crowds, through phone apps and other means, to the locations of DHS/ICE enforcement operations. The result has been physical violence and threats of violence against DHS/ICE agents.

The BOS should formally rebuke, as an agendized item, the Third District Supervisor for her comparison of DHS/ICE agents to the Nazi SA. Failure to do so gives tacit approval to the reprehensible conduct of the Third District Supervisor, and the dangerous demonization of federal law enforcement acting under the lawful authority of Congressionally approved statutes.

On another issue, approving federally funded benefits to illegal aliens through FQHCs, likely includes providing benefits to members/associates of transnational terrorist organizations. Out of the estimated 7,500 people with "unsatisfactory immigration status," receiving benefits through county administered FQHCs, perhaps 6,500 or more, are illegal aliens. Considering how active transnational terrorist organizations are in Santa Barbara County, and how deeply embedded they are in the illegal alien community, it is difficult to believe that the county is unaware it is providing benefits to members/associates of transnational terrorist organizations. Counting all federally funded benefits, at least 7,500 illegal aliens are receiving benefits, including members/associates of transnational terrorist organizations. It is a federal crime to provide assistance to members of transnational terrorist organizations.
