Set hearing for the March 6, 2012 Departmental Agenda to consider Case No. 11TEX-00000-00032 for the Miramar Beach Resort & Bungalows Amended Project Time Extension (time estimate 20 minutes; 5 minute staff presentation):

On March 6, 2012, your Board's action should include the following:

- 1. Make the required findings for approval of the project specified in Attachment A of the Montecito Planning Commission staff report dated February 3, 2012, including the California Environmental Quality Act (CEQA) findings.
- Accept the previously certified environmental review documents [Addendum dated March 15, 2011 together with the focused Environmental Impact Report (08EIR-00000-00003), Mitigated Negative Declaration (00-ND-003) and Addendum dated December 9, 2008], included as Attachment C of the Montecito Planning Commission staff report dated February 3, 2012, as adequate Environmental Review for Case No. 11TEX-00000-00032, under CEOA Guidelines Section 15162.
- 3. Approve the project, Case No. 11TEX-00000-00032, a one-year time extension from March 15, 2012 to March 15, 2013 of Case No. 11CDH-00000-0000.
