#### **Recommendations:**

That the Board of Supervisors:

- 1. Dismiss the Tompkins appeal of the Montecito Planning Commission decision on the Miramar Hotel Time Extension as the appellant did not articulate a legally sufficient basis for appeal, leaving the Montecito Planning Commission's approval of a one-year time extension for the Miramar Hotel Final Development Plan Amendment located at 1555 South Jameson Lane, APNs 009-333-010, 009-371-003, 009-371-004, 009-372-001, 009-010-002, First Supervisorial District in place; **OR**
- 2. Set a hearing to consider the Tompkins appeal of the Montecito Planning Commission approval of a one year time extension for the Miramar Hotel Final Development Plan Amendment located at 1555 South Jameson Lane, APNs 009-333-010, 009-371-003, 009-371-004, 009-372-001, 009-010-002, First Supervisorial District.

**Alignment with Board Strategic Plan:** The recommendation(s) are primarily aligned with actions required by law or by routine business necessity.

### **Executive Summary and Discussion:**

On March 16, 2005, the Montecito Planning Commission approved a one-time, one-year time extension for the Miramar Hotel Final Development Plan Amendment, case number 02AMD-00000-00007, based on the findings and conditions set forth in the Montecito Planning Commission Action Letter dated March 22, 2005, the requirements of Article II of Chapter 35 of the County Code, and the project's consistency with the policies and development standards of the Local Coastal Plan and the Montecito Community Plan. On March 28, 2005, Stephan Tompkins submitted an appeal of the Montecito Planning Commission approval. A copy of the appeal and the Planning Commission's record is attached.

Staff recommends that the Board dismiss the appeal as the appellant did not submit a legally sufficient basis for the appeal as part of his filing. This dismissal of the appeal leaves the Planning Commission's decision in place.

#### **Mandates and Service Levels:**

Section 35-182.3.1 of Article II (the Coastal Zoning Ordinance) of Chapter 35 of the County Code provides that the decisions of the Planning Commission may be appealed to the Board of Supervisors.

# **Fiscal and Facilities Impacts:**

As this project is located within the state-designated Appeals Jurisdiction of the Coastal Zone, no appeal application fee is required per the Planning & Development fee schedule (Resolution No. 96-323, adopted by the Board of Supervisors on August 6, 1996). Therefore, the entire cost of processing this appeal represents a net County cost borne by the Department.

If recommendation 2 is selected, the Clerk of the Board shall complete noticing in the Santa Barbara News Press and shall complete the mailed noticing for the project at least ten (10) days prior to the hearing (mailing labels attached.)
