SUBJECT: Request for Confirmation of Award to Local Vendor regarding Purchase of Vehicles

Recommendation(s):

That the Board of Supervisors:

Authorize the Purchasing Agent to purchase up to 14 Crown Victoria vehicles and one F-350 pickup-truck from Mel Clayton Ford., a local vendor, and a ¾ ton 4 X 4 from Iverson Motors even though the price with tax exceeds (by 0.6%) the price from a non-local source.

Alignment with Board Strategic Plan:

The recommendation is primarily aligned with Goal Number IV: A Community that is Economically Vital and Sustainable.

Executive Summary and Discussion:

Under the County's Local Vendor Outreach Program, the General Services Purchasing Division has actively pursued ways to keep the County's tax dollars circulating within the local economy. We have hosted workshops, presented speeches, made changes to our internal procedures, and instituted other measures to ensure that whenever it is prudent and economically feasible to do so, we buy from local vendors.

In the case before you, we are asking for reaffirmation of our policy of including sales taxes as a factor when making our awards. Fifteen of the vehicles being procured in this year's fleet order are priced so close between local vendors and non-local vendors that the difference in allocation of the State Sales Tax has a direct impact on the determination of lowest price.

Awarding these vehicles to a local vendor will allow us to spend \$364,204 within our borders, but will cost the county \$2,333.48 more than if we accept the otherwise-lowest offer. The added cost represents less than one per cent of the total cost. As a direct consequence of this award, over \$5,463 will be shared by the City of Santa Barbara and the County through the distribution of Sales Tax revenue. Furthermore, there are financial benefits to the overall economy when we deal with local vendors.

There was specific language in the "Invitation for Quote (Bid)" that advised prospective bidders that potential tax advantage to the County might be used as a factor in determining the award. Other factors which play into a close decision involving local versus non-local purchase of vehicles include more ready assistance in dealing with potential transit damage, missing items (hubcaps, spare tires, etc.) and paperwork corrections, as well as an inducement for higher priority responsiveness on warranty and recall work. All told, we believe that there is ample justification for the recommended action.

Mandates and Service Levels: Procurement of new vehicles under advantageous conditions is a business necessity

Fiscal and Facilities Impacts: Approving this recommendation will cost the county \$2333.48 more than if we made the award to non-local vendors. As a result of the proposed approach, however, the local government will receive over \$5,100 in Sales Tax distributions from the State.

The vehicles will be paid from the General Services Vehicle Operations and Maintenance Internal Service Fund (1900).
