RECOMMENDATIONS

That the Board of Supervisors:

Adopt a resolution establishing a one directional stop control at the intersection of Boardwalk Lane (southbound) and Via Santa Maria in the Orcutt area.

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure and Goal

EXECUTIVE SUMMARY AND DISCUSSION

The intersection of Boardwalk Lane (southbound) and Via Santa Maria is located in the eastern part of Orcutt. These two (2) roadways are both minor collectors. The intersection of Boardwalk Lane and Via Santa Maria is currently without stop controls in all directions. Vehicles approaching this three-legged intersection from Boardwalk Lane (southbound) and exiting onto Via Santa Maria have restricted sight distance looking east due to the contour of the roadway and foliage growing along side it. Based upon our investigation and the sight distance restrictions at this intersection, it was determined that a one-directional stop control, be established on Boardwalk Lane (southbound). The Public Works, Traffic Section has prepared the attached resolution to establish a one-directional stop control at the following intersection:

- On Boardwalk Lane (southbound) at its intersection with Via Santa Maria.
