# **BACKGROUND**



- Public Safety Realignment began in October 2011
- Goal is to reduce state prison population and provide local services that reduce crime in the future
- Board has been provided with monthly status reports
- Board requested quarterly public briefings on trends
- Ongoing collaborative effort

# INCREASED POST RELEASE COMMUNITY SUPERVISION (PRCS) OFFENDERS



Offenders returning have been greater than projections

Projection=180 (through March) Actual=225

#### Why:

Conversion of in-custody parole violators to PRCS

# Impact:

Increased need for supervision and services

# Response:

Probation shifted allocated resources

# LOCAL SENTENCING OF NON SERIOUS, NON VIOLENT, NON SEX OFFENDERS (NX3)



NX3 offenders being sentenced locally are currently lower than projections

Projection = 132 Actual = 106 Straight Sentence = 81 Split Sentence (PSS) = 25

# Why:

System still gaining familiarity with options


#### Impact:

 Limited use of PSS has resulted in greater use of bed days and no treatment efforts to address recidivism

#### Response:

On-going education on sentencing options

# **INCARCERATION TRENDS**



Jail is experiencing higher than projected numbers of AB 109 inmates in the jail.

On March 31st, 151% of full roll-out

# Why:

- Higher parolee impact
- Straight sentences vs. split sentences

#### Impact:

- Rising average daily population in the jail
- Increased stress on resources

# Response:

- Briefed DA's office on advantage of split sentences
- Increasing alternative sentencing programs
- Reconfiguring housing in Main Jail

# **SPENDING TRENDS**



Funds have not been expended as quickly as anticipated *Why:* 

- Hiring delays
- Negotiations and requirements of contracts
- Providers lack capacity or don't meet requirements


#### Impact:

- Treatment not readily available
- North County jail used only as a booking station

# Response:

- Continued collaboration with partner agencies
- Streamlining of the contracting process

# KEY OPERATIONAL IMPACTS



Larger than expected number of prisoners from the state prison system

- Higher than expected number of AB109 sentences to County Jail only and alternatives
- Spending of AB 109 funds has been slower, but is accelerating
