SUBJECT: Construction of Bell Street Bridge No. 51C-0157 Replacement and Approach Roadway at San Antonio Creek Near the Town of Los Alamos, California. Federal Project No. BRLSZD-5951 (070) in the Third Supervisorial District of Santa Barbara County, County Project No. 862042.

Recommendation(s):

That the Board of Supervisors:

Accept Notice of Completion for work performed by the Contractor, Whitaker Contractors, Inc. (Not A Local Vendor), P. O. Box 910, Santa Margarita, California 93453, and authorize Clerk to record.

Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Goal No. 1, An Efficient Government Able to Anticipate and Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

The project consisted of replacing the existing eight span, 320-foot long steel girder and concrete bridge originally built in 1932 over San Antonio Creek. The new structure is a 113 feet long single-span bridge. The project was designed to convey the 100-year storm event and to accommodate two 11.81-foot wide lanes and two 4.92-foot wide shoulder/bike lanes on each side of the bridge. This project began on June 9, 2003 and the Director of Public Works accepted this project as complete on March 11, 2004. The project was completed on time and on budget.

Your Board approved this project as part of the 2002/2003 Capital Improvement Plan.

Mandates and Service Levels:

No change in programs or service levels.



Fiscal and Facilities Impacts:

The Highway Bridge Replacement and Rehabilitation (HBRR) program provided 80% of the funding for this project, and the remaining 20% was provided by Measure 'D' monies. Measure 'D' funding for the project was budgeted in Fund 0015, Department 054, Account 7511, Org Unit 0002, and Program 2900.
