WHEREAS, tens of thousands of area residents and visitors have been enriched and inspired by their visits to the Wildling during the past 15 years; and

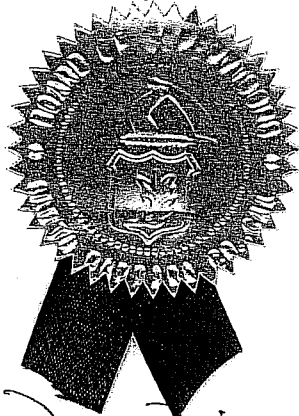
