**FIRST AMENDMENT TO GROUND LEASE AGREEMENT**  
**TEMPORARY EMERGENCY HOUSING**

**THIS FIRST AMENDMENT** (hereinafter, "Amendment") is made by and between:

The COUNTY OF SANTA BARBARA, a  
political subdivision of the State of  
California, hereinafter referred to as  
"COUNTY,"

and

GOOD SAMARITAN SHELTER, a  
California public benefits 501 (c) (3)  
nonprofit organization and existing  
under the laws of the State of California  
hereinafter referred to as "GOOD  
SAMARITAN"

with reference to the following:

**WHEREAS**, COUNTY is the fee owner of that certain real property and improvements in the City of Santa Barbara, State of California, located at 1016 Santa Barbara Street, more particularly described as County Assessor's Parcel Number. 029-212-019, (hereinafter "Property"); and

**WHEREAS**, GOOD SAMARITAN performs programs necessary to meet the social needs of the population of the County by providing an interim supportive housing community, temporary emergency housing units, related facilities, and associated programs, and services necessary to assist the homeless population of the COUNTY ("Project") located at the Property; and

**WHEREAS**, pursuant to California Government Code Section 26227 and Santa Barbara County Code 12A 10.3, COUNTY leased the Property to GOOD SAMARITAN, at no cost to GOOD SAMARITAN, for the purpose of GOOD SAMARITAN providing, maintaining and operating the Project; and

**WHEREAS**, COUNTY and GOOD SAMARITAN entered into a Ground Lease Agreement ("Agreement") in February 2022, for a period of three (3) years, terminating on June 30, 2025; and

**WHEREAS**, COUNTY and GOOD SAMARITAN intend to amend the Agreement by this First Amendment to modify the Term of the Agreement; and

**NOW, THEREFORE**, in consideration of the Premises and the provisions, covenants, and conditions set forth herein, COUNTY and GOOD SAMARITAN hereby agree as follows:

1. Section 4 of this Agreement (TERM), is hereby amended by replacing the first sentence of Section 4 to read in its entirety as follows:

4. **TERM:** Provided GOOD SAMARITAN is in compliance with all terms and conditions of this Agreement, the term of the Agreement (hereinafter “Term”) shall begin on July 1, 2025, and terminating on June 30, 2027.

2. It is expressly understood that in all other respects, the terms and conditions of the original Lease Agreement, dated February 8, 2022 shall remain in full force and effect.






