#### **Recommended Actions:**

That the Board of Supervisors:

- a) Approve the donation of surplus County vehicle #4337 to Allan Hancock Joint Community College District (District); and
- b) Determine that the above-recommended action does not constitute a project subject to environmental review under the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15378(b)(5) because it is an organizational or administrative activity that will not result in direct or indirect physical changes in the environment.

#### **Summary Text:**

The Fire Department would like to donate and transfer title of one surplus Type 1 engine to the District at the asset salvage value of \$14,678. This donation will allow the surplus vehicle to be put to purposeful use for many years as a training tool that will benefit the County as a whole.

# **Background:**

The Fire Department proposes to donate one surplus Type 1 engine that is fully depreciated, scheduled for salvage, and recently replaced by another engine for the Fire Department's purposes; therefore, it is no longer required for County use. The District proposes to use the surplus engine as a training aid in its

Firefighter training program and Structural Firefighting training it provides in its Fire Academy. Government Code §25365 authorizes the Board of Supervisors, by a four-fifths vote, to donate County real or personal property to any public agency, including school districts, if the property to be granted and conveyed is not required for County use. Allan Hancock College is a joint community college district. A letter of interest from Allan Hancock College is attached, requesting consideration for the vehicle.

# **Narrative:**

The Fire Department will refund the salvage value for vehicle #4337 back to the Vehicle Operations Fund. This salvage value was originally credited to the Fire Department when the new Type 1 engine was placed in service. Since the old engine (#4337) will no longer be going to auction with the auction proceeds being recovered by the fleet fund, the Fire Department will need to return the salvage value that was taken by the department when the vehicle true-up transactions were originally recorded.

The Fire Department will absorb this cost within existing FY 2021-22 appropriations.
