**RECITALS**

WHEREAS, on November 28, 2022, the Montecito Fire Protection District adopted Ordinance No. 2022-01 which adopted and amended the 2022 California Fire Code; amended Section R313 of the 2022 California Residential Code; amended Section 1505 of the 2022 California Building code; and repealed Ordinance No. 2019-02. The adopted building standards are more stringent than those building standards contained in the 2022 California Fire Code and 2022 California Residential Code. A copy of Ordinance No. 2022-01 is attached to this resolution and incorporated by reference.

WHEREAS, the Montecito Fire Protection District adopted findings in Article 11 of Ordinance No. 2022-01, which set forth that the adoption of the Ordinance is reasonably necessary because of local climatic, geological, and topographical conditions. The findings were adopted in accordance with Health and Safety Code Section 13869.7.

WHEREAS, in accordance with Health and Safety Code Section 13869.7 the Board of Supervisors may ratify, modify or deny the Montecito Fire Protection District District's Ordinance No. 2022-01.

WHEREAS, upon ratification of Ordinance No. 2022-01, the County shall submit a copy of this resolution and Ordinance No. 2022-01 with the findings set forth in Article 11, to the California Department of Housing and Community Development.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Board of Supervisors:

1. The above recitals are true and correct.
2. The Montecito Fire Protection District Ordinance No. 2022-01 is ratified.


