#### **Recommended Actions:**

Adopt a "Resolution Supporting Health Reform to Restore the Partnership between Counties and the Federal Government."

#### **Summary Text:**

The National Association of Counties (NACo) has been instrumental in advocating for reform of the health system, including restoring the partnership between counties and the federal government. As part of this effort, the organization is requesting counties to support health reform by adopting a resolution that supports NACo's health reform principles. As illustrated in the attachment, the resolution endorses the need for health reform; however, it does not advocate for a specific health care proposal or legislation currently being deliberated by Congress.

On August 21, 2009, the County's Legislative Program Committee, which consists of Supervisor Carbajal (County's NACo Representative), Supervisor Wolf (member of NACo's Health Steering Committee), Auditor-Controller Bob Geis, County Executive Officer Michael F. Brown, and County Counsel Dennis Marshall, voted 5-0 to bring this item to the Board for consideration of support.

### **Background:**

NACo's guiding principles for health reform are articulated in the attachment entitled "Restoring the Partnership for American Health: Counties in a 21st Century Health System" and include promoting county partnership; ensuring access and delivery of quality health services to all; focusing on disease and injury prevention, expanding universal health insurance coverage through public systems like Medicare, Medicaid and SCHIP; ensuring a "safety net" for Medicaid; supporting and enhancing a

health professional and paraprofessional workforce; supporting the integration of IT into the health care delivery system; supporting long-term care and community-based services for the elderly and disabled and reforming health care in the jails.

# **Fiscal and Facilities Impacts:**

### **Fiscal Analysis:**

Narrative: There is no fiscal impact to the County of supporting the resolution. Comprehensive reform of the health system will have fiscal impacts on the County, which are not analyzed as part of this agenda item. Currently, the County incurs costs related to fulfilling health obligations, such as:

- The number of indigent clients receiving mental health services has increased from 1,988 clients in fiscal year 2002-03 to 2, 544 clients in fiscal year 2007-08. These 2,544 clients represented about 38% of the open cases. The County's cost of indigent care ranged from \$3.8 million in fiscal year 2002-03 to \$4.6 million in fiscal year 2007-08, and peaked to \$5.5 million in fiscal year 2006-07.
- Public Health provides services to approximately 20,500 patients annually at a cost of \$16 million. The uninsured/underinsured population receives specialty services such as OB/Gynecology orthopedic, infectious disease, surgery, arthritis, diabetes, and dermatology, which are provided by Public Health's primary care and urgent care clinics.
- The Sheriff's Department has budgeted \$4.3 million to provide health-related services to inmates housed within the County jail.
