That the Board of Supervisors:

Adopt a resolution authorizing the Santa Barbara Community College District to issue and sell bonds directly, in accordance with Education Code section 15140(b), in an amount not to exceed \$30,242,000.

Summary Text:

On June 3, 2008, the requisite 55% of qualified voters in the Santa Barbara Community College District authorized the District to issue General Obligation bonds in an amount not to exceed \$77,242,012.

Background:

The District is preparing to issue the bonds, "Santa Barbara Community College District, General Obligation Bonds, Election of 2008, Series B" in an amount not to exceed \$30,242,000 as authorized by the voters in "Measure V". Series A, in the amount of \$47,000,000, was issued in December 2008.

The Santa Barbara Community College District will be liable for repayment of the bonds. Santa Barbara County will levy and collect the taxes and make the payments, as required by Education Code Section 15140(b).
