I learned programming in 1972 and maintained an interest in learning information technology. There is so much I don't know, but I have more info-tech affinity than most people, especially my age. I'm adept at Excel, PowerPoint, but I'm a novice at relational databases and website development. I'm no help with networking or system administration. But I should be able to assist the board in understanding many technical topics. .. As an info junkie, I am sure I'm in the 99% tile in the number of documents, presentations, info-graphics, podcasts contained in my halfdozen large personal digital libraries. (Please don't ask about my hardfile collections.) I am passionate about data>info>knowledge>understanding. \*\*\* I have developed a process-based-framework for improving the quality of knowledge. \*\*\* This grew out of my key role in an international collaborative effort to create a knowledge commons for one of the subjects I'm interested in.

I feel this is my best qualification for being on this board: I come with no agenda to advocate, no schoolof-library-philosophy to bias me, nor interest group to be loyal to. I acknowledge the merits of specialization, as an organization can't be everything to everybody. I have a history of being the swing board member who listens to all the others -- often in two camps -- and formulates a perspective and an alternative that moves us forward. My professional motto is "Dedicated to the True customer." (Reference Edward Deming and Total Quality Management.) So my primary goal is to learn, listen, and collaborate on developing a pragmatic strategic plan to guide Library investment, development, programs and operations that best serve the diverse stakeholders of the Goleta Library. .. I am creative, forward looking, and have a bias toward innovation. I believe in pilot programs. Lean and agile methods/concepts may be appropriate. To save time and funds, I will look to see how well other Libraries' initiatives are working, but will question if programs successful elsewhere are right for us. And I'm understanding change takes time. .. But for something more concrete, I would be pleased if a 2025-2030 outcome of implementing the strategic plan, was for the Library to be a key institution for - improving No/Goletian's individual, tribal, and collective ability to move forward together for civic mutual benefit, by improving decision making, voting outcomes, life-choices, by - improving our abilities to evaluate data and information into accurate/reliable agreed-upon knowledge and wise understanding of causes and effects, and better assessment of risks and rewards.
