I am writing as a resident and community member of Santa Barbara County, from District 1. I have been participating in County Board meetings and City Council meetings for year, ever since supervisors and city council members made commitments to do better at supporting Santa Barbara county's Black / African American community. I have seen almost none of those commitments come through, regardless of the persistence this community has shown in supporting Healing Justice and their demands.

Healing Justice has continued to persist in uplifting and strengthening this community regardless of receiving no funding--besides a measly DEI consulting contract-- jumping through ridiculous bureaucratic hoops that don't seem to exist for anyone else, and have been left out of important conversations concerning the money the county set aside for Racial Equity, conversations that they centered with their organizing and activism. What does the county have to actually show for the \$500,000 they set aside for racial equity? I've listened to the presentations, there is nothing that actually uplifts those who are directly impacted by the lack of racial equity in the county in meaningful, impactful, and concrete ways. Equity means that everyone is provided with the tools they need in order to succeed, and yet provision seems to have been sacrificed for a version of equality that only exists on paper. It's time to invest in actual concrete ways of supporting Black / African American residents of the county. Use the remaining \$270,800 to invest in preserving Black futures and Black History, through the cultural center.

The time is now, this is how we uplift our community and truly invest in racial equity. This is your opportunity to make sure your promises are not empty, and this funding is long overdue. This community has continued to show up for Healing Justice, we have continued to make our voices heard, and it's clear now a year later that we aren't going anywhere.
