#### **Recommended Actions:**

Receive an annual report from Thomas Walters and Associates regarding federal legislative activities.

### **Summary Text:**

Each year the Board of Supervisors identifies specific issues, projects and/or programs (priorities) that warrant targeted legislative advocacy and includes these priorities are part of its legislative platform for the upcoming calendar year. Once the platform is adopted by the Board, staff determines various legislative strategies centered on the identified priorities such as enacting or amending legislation, creating partnerships with federal agencies and exploring funding opportunities. One component of the County's legislative strategy has been to utilize the advocacy services of Thomas Walters and Associates to assist the County in implementing the legislative platform at the federal level.

### Background:

This item is before the Board to receive a report on the key legislative actions that transpired at the federal level in 2010 that directly impacted the County (see attachment). The annual report contains a summary of federal legislation monitored on behalf of the County and the status of various appropriation requests related to County infrastructure and capital projects.

#### Performance Measure:

The measure associated with this contract is contained within the CEO Department Summary for the Legislative Advocacy program (page D-35 of the FY 10-11 Operating Plan), and states, "To seek Annual Federal Legislative Report January 11, 2011 Page 2 of 2
