Sheriff: Release \$26,847 of designation and appropriate to Fixed Assets to finish the build out of a UH-1H Helicopter for use by the Sheriff's Department (Copter 3).

In October 2006 the Sheriff's Council donated \$950,000 to the Sheriff's Department to pay for the build up and refurbishment of a UH-1H Huey helicopter to be used as an unrestricted rescue and emergency operations resource. Through June 30, 2009, \$923,153 of work was completed on the aircraft. Delays in airframe work caused the project to continue into FY2010-11. This revision releases the remaining designated donated funds (LI 9786) for this project and appropriates them in line item 8300, Fixed Assets to complete the project.
