Recommended Action(s):

Adopt a resolution establishing a "No Parking" zone on Clark Road in the unincorporated area of Santa Barbara.

Summary:

Clark Road is a minor residential roadway running north and south in the Santa Barbara area with fronting residences on the east and west sides of the roadway. The Public Works Traffic Section has performed a site visit at this location, and based upon the results of this visit they are in agreement that a "No Parking Zone" at this location would create a safer environment for those traveling and residing on Clark Road. The island will cause drivers to slow their speed to execute a left or right turn from Pueblo Avenue on to Clark Road and vice versa. In order to provide an adequate travel width for cars traveling around the island, a "No Parking" zone must be installed on the east and west sides of Clark Road in the proximity of the island.

The Public Works Traffic Section has prepared the attached resolution establishing a "No Parking" zone at the following location:

 On both sides of Clark Road from the centerline of Pueblo Avenue to a point 80 feet north of the centerline of Pueblo Avenue.

Background:

A proposed asphalt island on Clark Road is the second phase of a two phase traffic calming project located at the corner of the Pueblo Avenue and Clark Road intersection. In phase one, 4 speed humps were installed on Pueblo Avenue to control vehicle speeds in this residential neighborhood. Phase 2 of this traffic calming project serves to reduce speed on Clark Road at its intersection with Pueblo Avenue.
