# Recommended Action(s):

Adopt a resolution establishing a "No Parking" zone on La Cumbre Road at Pueblo Avenue in the Santa Barbara area.

### **Summary:**

La Cumbre Road is a major residential roadway in the San Roque area that forms a T-intersection with Pueblo Avenue. The Public Works Traffic Section has been asked to prepare the attached resolution establishing a No Parking zone at the following location:

- On the east side of La Cumbre Road from a point 186 feet south of centerline of Pueblo Avenue to a point 217 feet south of the centerline of Pueblo Avenue.
- On the east side of La Cumbre Road from a point 259 feet south of centerline of Pueblo Avenue to a point 349 feet south of the centerline of Pueblo Avenue.

#### Background:

A complaint was received requesting that a "No Parking" zone be established on the east side of La Cumbre Road south of Pueblo Avenue to help improve sight distance for motorists entering and exiting Las Brisas gated community. Based upon our investigation of this site, it was determined that creating a "No Parking" zone at this location (see vicinity map) would increase sight distance and improve public safety for those residing and traveling on La Cumbre Road.
