That the Board of Supervisors:

Approve and execute a License Agreement with Southern California Edison Company, to allow installation of traffic regulating signs, American flags and Neighborhood Watch signs, banners and related appurtenances on streetlights and electric poles on Lillie Ave in the town of Summerland.

Summary Text:

The Department received a request from the Summerland Citizen's Association (SCA) to place banner holders on the newly installed streetlights along Lillie Ave in the town of Summerland. The SCA would like to hang American Flags from these streetlights to celebrate the 4th of July, as well as other banners throughout the year. The maintenance for these streetlights is the responsibility of Southern California Edison (SCE) and thus SCE is requiring that the County enter into a licensing agreement with SCE to allow banners to be hung on these streetlights. The streetlights were installed as part of the Summerland Circulation Improvement project. By executing this licensing agreement with SCE, the County can allow the SCA to place banners on the streetlights through a Road Encroachment Permit. The Department will work with the SCA to ensure that the banners are appropriate and do not result in a traffic safety issue.
