SUBJECT: No Parking 2AM to 5AM Zone on Eucalyptus Lane. First Supervisorial District.

RECOMMENDATIONS:

C.A. Recommendation: _____

That the Board of Supervisors adopt a resolution establishing a “No Parking 2AM to 5AM” zone on Eucalyptus Lane in the Montecito area.

ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

EXECUTIVE SUMMARY & DISCUSSION:

Eucalyptus Lane is a 24-foot wide minor residential road south of South Jameson Lane that ends in a cul-de-sac near the ocean in Montecito.

A request was received from a property owner on Eucalyptus Lane asking the County to implement “No Overnight Parking” on the east and west side of Eucalyptus Lane, south of Humphrey Road in the cul-de-sac that provides beach access parking. Vehicles are often parked overnight at this location which restricts parking for residents and visitors. To create a safer and healthier environment, the Public Works Traffic Section has been asked to prepare the attached resolution establishing a No Parking 2 AM to 5 AM zone at the following location:

On the east and west side of Eucalyptus Lane, from a point 180 feet south of the centerline of Humphrey Road to a point 230 feet south of the centerline of Humphrey Road.
