This Second Amendment to Subrecipient Agreement ("Second Amendment") is made and entered into by and between the County of Santa Barbara (the "COUNTY"), a political subdivision of the State of California, and Good Samaritan Shelter, a California nonprofit public benefit corporation (the "SUBRECIPIENT" and together with the COUNTY, collectively, the "Parties" and each individually a "Party"), whose address is 400 W. WITNESSETH THAT:

WHEREAS, the COUNTY and SUBRECIPIENT are parties to that certain Subrecipient Agreement dated August 30, 2023 (the "Agreement"); and

WHEREAS, the Parties desire to amend the Term of the Agreement as set forth in Section II.A. of the Agreement to extend the Term until June 30, 2025.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties hereto agree as follows:

- 1. Section II.A. of the AGREEMENT is hereby amended by replacing Section II.A to read in its entirety as follows:
 - "A. Time of Performance

The term of this Agreement shall begin on August 30, 2023 ("Operating Start Date"), and shall terminate on June 30, 2025, unless earlier terminated in accordance with the provisions of this Agreement or there are insufficient ARPA funds available for any reason ("Term"). All Services to be performed hereunder and set out in the Scope of Services may commence on the Operating Start date and shall terminate on June 30, 2025 Any funds available but not expended hereunder by June 30, 2025, will thereafter no longer be available to the SUBRECIPIENT and shall be returned to the COUNTY."
