SUBJECT: No Parking Zone on South Padaro Lane in the First Supervisorial District.

RECOMMENDATIONS:

C.A. Recommendation:

That the Board of Supervisors adopt a resolution establishing a No Parking Zone on South Padaro Lane in the Summerland area

ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

EXECUTIVE SUMMARY & DISCUSSION:

South Padaro Lane is a major rural two-lane roadway in the Summerland area. A request was received from the Padaro Association to restrict parking on South Padaro Lane, south of the 101 northbound off ramp. Vehicles frequently park along the east shoulder of South Padaro Lane under the bridge in order to access the beach and creating a sight obstruction for vehicles turning left from the 101 off ramp. Based upon our investigation of this site, it was determined that creating a "No Parking" zone at this location (see vicinity map), would create a safer environment for those traveling on South Padaro Lane. The Public Works Traffic Section has prepared the attached resolution to establish a "No Parking" zone at the following location:

• On the east side of South Padaro Lane from a point 176 feet north of the centerline of Santa Claus Lane to a point 226 feet north of the centerline of Santa Claus Lane.
