






## Public Private Collaboration...



# Next Steps...

### **Proposed Substance Abuse Coordinating Council (SACC)**

**Purpose:** MLC/SACC's Coordinating Council would determine overall policy and direction. The Council would meet at least two times annually or as needed.

#### Membership could include:

- Representatives from community coalitions engaged in substance abuse issues
- Representative from county departments impacted by substance abuse
- Representatives from cities in the county
- Representatives from various boards and/or councils

**Transition & Support**: will be lead by the Alcohol & Drug Program division of Alcohol, Drug & Mental Health Services
