The recommendations are primarily aligned with Goal No. 1, An Efficient Government Able to Anticipate and Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

This project was part of the annual County Wide, Preventive Maintenance Program of the Department. It consisted of the repair of the existing hardscape by removing 332 square feet of damaged parkway concrete, installing 16 federally-mandated curb ramps, and providing tree root pruning and shielding. It also included the repair and construction of approximately 532 linear feet of sidewalk, 1,040 linear feet of curb and gutter, and several cross gutters, spandrels, driveways, and driveway aprons.

Your Board approved the project as part of the FY 2004/2005 Capital Improvement Plan. The specific project locations were approved by your Board in the FY 2004/2005 Road Maintenance Annual Plan (RdMap) and are attached for your information.

This project was bid in accordance with the Public Contract Code, which requires the Department to award to the lowest responsible bidder.

The Director of Public Works accepted this project as complete on February 22, 2005. The project was completed on time and on budget.
